18 **DEBTOR'S OBJECTION TO CLAIMS OF CITIBANK, N.A.**  
19 **AS TRUSTEE FOR THE CERTIFICATEHOLDERS OF STRUCTURED ASSET**  
20 **MORTGAGE INVESTMENTS II INC., BEAR STEARNS ALT-A TRUST, MORTGAGE**

23 COMES NOW, RICKIE WALKER, and files this Objection to Proof of Claim  
24 number 0002497618 as filed by the alleged Creditor, CITIBANK, N.A. AS TRUSTEE FOR  
25 THE CERTIFICATEHOLDERS OF STRUCTURED ASSET MORTGAGE  
26 INVESTMENTS II INC., BEAR STEARNS ALT-A TRUST, MORTGAGE PASS-  
THROUGH CERTIFICATES SERIES 2007-3, BY EMC MORTGAGE CORPORATION  
AS ATTORNEY IN FACT pursuant to Bankruptcy Rule 3007 and states the following:

1 A security interest in the property of the debtor is claimed, however, the proof of  
2 claim is not accompanied by evidence that the creditor has authority to bring the claim, has  
3 standing or that the security interest has been perfected as required under F.R.B.P. Rule  
4 3001(d) and is facially defective and does not constitute prima facie validity of the claim.

5 The proof of claim does not set forth the creditor's claim with proper specificity,  
6 pursuant to F.R.B.P. Rule 3001(a) & (c).

7 WHEREFORE, the Debtor objects to Claim number 0002497618 as filed by the  
8 Creditor and respectfully requests this Court enter an order requiring the Claimant to file an  
9 amended claim to correct the defect within 30 days and if not corrected, upon expiration of  
10 that time, the claim is disallowed in its entirety.
